

FULL TERMS & CONDITIONS

These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. - 4. 4. Please retain packaging showing code and purchase receipt as it will be required to validate the qualifying purchase in the case of winning a prize.**
